The UK's departure from the EU forced businesses to radically adjust to new barriers to trade, but David remains energised to make a positive contribution to the future trade relationship, and to help companies and organisations on both sides of the channel to trade and invest as frictionlessly as possible. UK and Belgian ports and infrastructure links are critical routes for European and UK supply chains and the close geographic proximity means the flow of goods, people and energy will continue to be enormously important to both jurisdictions.

David previously worked at the European Commission in DG FISMA and the Financial Services Authority in the Chairman's office working on international affairs. He started his career in London, working as a research analyst with McKinsey & Company and at placement agent and corporate finance advisory firm Campbell Lutyens.

What would I bring as Co-President of the British Chamber of Commerce EU/Belgium?

I think there is something very special about this Chamber, and I say this as someone who works with other chambers, associations and business coalitions. It is not a nationally focused trade association nor a

mouthpiece for government. It is a voice of business that has an interest in the UK/EU and UK/Belgium relationship. This makes the Chamber a unique actor in Belgium.

I would bring an energetic and creative business perspective on the importance of facilitating trade between the UK, Belgium and the EU. The core of my day job is to make the case for investment and trade. This couples with my dual-national status, meaning both my professional and my private life is centred around Europe and Belgium's relationship with the UK.

My primary focus as Co-President would be on the Bilateral side of the Chamber, but I would be able to support Elizabeth as co-President for EU-facing work. I would encourage others within the Chamber membership to volunteer to support the work of the Bilateral chamber. I have been lucky to work with Hugues Thibaut from SD Worx for 3 years as Chair and Vice Chair respectively. But a mission for us in the coming years is to broaden our networks and impact in the Belgian and British communities, and to connect with and leverage fully the public sector channels such as the Belgo-British Conference and future trade missions.

I also share colleagues' commitment to improve the diversity of the Chamber and intend to work on initiatives linked to women in particular. Working with Elizabeth, who will concentrate more on the EU side of the Chamber, means that we can drive forward clear pathways for both sides of the Chamber in parallel.

I see this proposed way of working as Co-Presidents as an evolution of the way we are already working now, rather than as an entirely new proposal. The degree of integration of daily work flow set by the Board and implemented via the Committees is already generating the crossovers we need throughout the Chamber work programme. But there is much more that we can do.

I therefore submit my candidacy to help lead the organisation on its next phase of development, integration and impact across both pillars of the Chamber. I hope I have the opportunity to speak to you all in due course to learn from your experience, to understand better your objectives in Belgium, in Europe, and in the UK, and to reflect this in the work of the Chamber.
