## Notes to the Proxy Form

- 1. As changes to the Articles of Association are being presented to the General Assembly for approval, Belgian law requires that 2/3 of the voting membership need to be present, in person or by proxy, to validly decide on these changes.
- 2. Each Member shall have the right to give a proxy to another Member to be represented at a meeting of the General Assembly. <u>No Member may hold more than two (2) proxies.</u>
- 3. The proxy may exercise all or any of your rights to attend, speak and vote at a general meeting. Only one vote is allowed per member company. You can only appoint a proxy using this form and the procedures set out in these notes.
- 4. Appointment of a proxy does not preclude you from attending the meeting and voting in person. If you have appointed a proxy and attend the meeting in person, your proxy appointment will automatically be revoked.
- 5. To direct your proxy how to vote on the resolutions, mark the appropriate box with an "X". If no voting indication is given, your proxy will vote or abstain from voting at his or her discretion. Your proxy may vote (or abstain from voting) as he or she thinks fit in relation to the limited range of additional resolutions which may be put before the meeting. These include for example:
  - i. resolutions to deal with procedural aspects of the meeting such as the calling of a poll or a decision to adjourn.
  - ii. resolutions proposing amendments to the items listed in the notice of the meeting, noting that the circumstances in which amendments can be made are very limited.
