

Short-Term Work Activities in the EU

UK nationals traveling to the EU for up to 90 days (within a 180-day period) will not require a visa.

**Business Travel:** A business trip which involves attending meetings or conferences, does not require a visa. You will need a visa if:

- Your work stay is longer than 90 days (within a 180-day period) or,
- You’re conducting an ‘intra-corporate transfer or,
- You’re self-employed and providing services in an EU member state, or
- You’re providing services in an EU member state, where your employer has no local presence.

What is the **Schengen Area**?

- The 26 European Countries that signed the Schengen Agreement include: **Austria, Belgium, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Italy, Latvia, Lichtenstein, Lithuania, Luxembourg, Malta, The Netherlands, Norway, Poland, Portugal, Slovakia, Slovenia, Spain, Sweden, Switzerland.**

UK nationals wanting to conduct short-term work activities in the EU are now considered third-country nationals and must now adhere to the short-term work requirements specified by each EU member state:

Belgium	<p>The following do not require a work permit/single permit in Belgium:</p> <ul style="list-style-type: none"> <li>• Scientific congress, inner circle meetings (negotiations, discussions, interviews etc) for 60 days maximum per year and 20 consecutive days.</li> <li>• Post-doctoral scholar (working for 90 days or less)</li> </ul>

	<ul style="list-style-type: none"> <li>• Artists of international reputation for <b>less than 90 days</b>.</li> <li>• Researcher (for the work duration stated in hosting agreement)</li> <li>• Domestic servants (who are accompanying tourists for 90 days or less)</li> <li>• Installer or assembler of goods and prototypes (developed by an accredited research institution, during at most four weeks a year)</li> <li>• Intern (working for 90 days or less)</li> <li>• Worker employed pursuant to an international agreement (for 90 days or less)</li> <li>• Journalist (living and working for a foreign media organization in Belgium for 90 consecutive days or less)</li> <li>• Commissions for military graves employees (working for 90 days of less)</li> <li>• Athlete, trainers, assistants, referee or official delegate participating in an international sporting event (for up to 3 months)</li> <li>• Religious officials (for 90 days or less)</li> <li>• Seaman (working for 90 days of less)</li> </ul> <p>(Source: <a href="https://economy-employment.brussels/permit-your-situation">https://economy-employment.brussels/permit-your-situation</a>)</p>
Bulgaria	<p>Artists</p> <ul style="list-style-type: none"> <li>• Freelance artists must obtain a 12 month ‘Freelance Activity Permit’ prior to their arrival.</li> </ul> <p>The following <b>can obtain a continuous work permit</b>:</p> <ul style="list-style-type: none"> <li>• Persons who engage in commercial activity in Bulgaria, by at least 10 jobs for Bulgarian citizens have been opened</li> <li>• Foreign specialists in the country under international treaties</li> <li>• Representatives of foreign companies</li> </ul> <p>The following <b>do not require</b> a work permit:</p> <ul style="list-style-type: none"> <li>• Managers of companies/branches of foreign entities</li> <li>• Boards of directors who do not work under an employment relationship</li> <li>• Commercial representatives of foreign companies</li> </ul> <p>(Source: <a href="https://invest.bg.government.bg/en/pages/1-entry-stay-and-work-of-foreigners-in-bulgaria-174.html">https://invest.bg.government.bg/en/pages/1-entry-stay-and-work-of-foreigners-in-bulgaria-174.html</a>)</p>
Croatia	<p>A ‘Stay and Work Permit’ is required for temporary work between 6-30 days per year. Cyprus	<p>Applications for work permits in Cyprus must be submitted to the Civil Registry and Migration Department by the employer and include:</p> <ul style="list-style-type: none"> <li>• Application forms M.58 and M.64</li> </ul>

Denmark	<p>A “<b>Special Individual Qualification</b>” application must be completed to be exempt from a work permit for up to 90 days and applies to:</p> <ul style="list-style-type: none"> <li>• <b>Performers or artists, such as singers, musicians or conductors.</b> <ul style="list-style-type: none"> <li>○ <i>“If you are of paramount importance to a significant artistic event you can work without a work permit”</i></li> </ul> </li> <li>• <b>Professional athletes and sports coaches</b></li> </ul>

Estonia	<p>Register for <b>‘long-term visa for a short-term employment’</b> before you arrive in Estonia with the Police and Border Guard Board.</p> <p>This short-term employment application is required if you are:</p> <ul style="list-style-type: none"> <li>● Participating in creative activities within a performing arts institution;</li> <li>● A teacher or lecturer in an educational institution;</li> <li>● A scientist with appropriate professional training or experience;</li> <li>● A sportsman, coach, referee or sports official for professional activities (based on an invitation from a respective sports federation);</li> <li>● A trainee obtaining vocational education overseen by a foreign educational institution or a student organization;</li> <li>● Serving in the diplomatic representation of a foreign country with permission from the Ministry of Foreign Affairs;</li> <li>● An au pair;</li> <li>● An expert, adviser or consultant with required professional training;</li> <li>● An installer of equipment or a skilled worker with required professional training;</li> <li>● A seasonal worker processing agricultural products.</li> </ul>

Finland	<p>The following activities can be conducted in Finland without a permit (provided the activity lasts no longer than 90 days):</p> <ul style="list-style-type: none"> <li>• ‘Product demonstrator or film worker (where your employer has no office in Finland)’</li> <li>• ‘Sailor (on a ship listed in the Register of Merchant Vessels or, on a ship that primarily operates between foreign ports)’.</li> <li>• ‘A permanent employee providing temporary work (for a company operating in another EU/EEA country)’</li> <li>• ‘A tour leader for a package tour with Finland as the destination’.</li> <li>• ‘Personnel for a vehicle owned or controlled by a foreign party, and: <ul style="list-style-type: none"> <li>○ You are transporting a load across the border to a certain destination, or;</li> <li>○ The operation in Finland is related to regular service between municipalities, where at least one is located abroad.</li> <li>○ You are not residing in Finland.’</li> </ul> </li> </ul> <p>(Source: <a href="https://migri.fi/en/work-without-residence-permit">https://migri.fi/en/work-without-residence-permit</a>)</p>
France	<p>No permit is required for the following work activities (provided the duration of stay is less than 3 months per year):</p> <ul style="list-style-type: none"> <li>• Sporting, cultural, artistic and scientific events.</li> <li>• Conferences, seminars and trade shows.</li> <li>• Production and distribution of cinematic and audiovisual works shows and recordings.</li> <li>• Modeling and artistic posing.</li> <li>• Personal service workers and domestic workers working in France during their private employers’ stay in the country.</li> <li>• Audit and consulting in IT, management, finance, insurance, architecture and engineering, under the terms of a service agreement or intra-company transfer agreement.</li> <li>• Occasional teaching activities by invited lecturers.</li> </ul> <p>(Source: <a href="https://www.welcometofrance.com/en/fiche/fact-sheet-work-permit">https://www.welcometofrance.com/en/fiche/fact-sheet-work-permit</a>)</p>
Germany	<p>It is still undetermined whether the UK will join the <b>European Travel Information and Authorization System (ETIAS)</b>, to be operational in 2021 and includes 62 countries who currently have a visa-waiver program with Germany.</p>

Norway	<p>The following individuals may work in Norway <b>(for a maximum of 14 days in a 12-month time period) without requiring a residence permit:</b></p> <ul style="list-style-type: none"> <li>• Performers, artists, musicians and their supporting teams (local police must be notified upon arrival).</li> <li>• Employees engaging in international humanitarian work in Norway,</li> </ul> <p>The following individuals may work in Norway <b>(for a maximum of three months) without requiring a residence permit:</b></p> <ul style="list-style-type: none"> <li>• Researchers and lecturers</li> <li>• Employees of international companies (with a branch in Norway)</li> <li>• Technical experts</li> <li>• Commercial and business travelers (to attend meetings, conferences and contract signings.</li> <li>• Medical practitioners</li> <li>• Religious preachers</li> <li>• Athletes and support teams</li> <li>• Journalists and photographers</li> <li>• Tour guides</li> <li>• Staff of international trains, busses, flights and ships.</li> </ul>
